# 43 Indian Rock Road

Mr. Ellingston, architect: elevations, architectural detail, fill out the right-side treatment and address visual features, berms, taller trees, front elevation, massing, visual impact, balance of gables, depth between face and gables, bike rack, "service" sign, removal of parking lot light pole signs. Mr. Scarnio, transportation engineer: ingress/egress, Route 111 traffic patterns, signalization, slip lanes, turn lanes, Route 111/North Lowell/Fellows intersection, level of service, volume-to-capacity ratio, queuing, deceleration lanes. Mr. Dubay: central landscaped aisle, wetland setbacks, fire lane, lane widths, road grades, trees, traffic calming, pedestrian access on-site and offsite, free-standing signs, white-blocking on internally illuminated signs, sign locations and features, land swap with NH DOT, multiple sign locations on plan, Route 111 vegetation and reconstruction impacts, land to the immediate west, water lines – present and future planning, ready-rock walls.
