Lot #21-K-16, 164 Range Road – Mr. Brendon Quigley of Gove Environmental

Discuss two changes suggested during the March 28, 2009 Site Walk.

A detailed cross section was added to illustrate the stone at the end of the path and bronze has been specified for the lower retaining pins to prevent corrosion.
