The Chairman appointed Mr. Rouillard to replace Dr. Anderson for this meeting.

2 Birchwood Road – John McRobbie

Remove fill to re-establish wetlands

Mr. McRobbie presented his restoration plan and explained that this is an isolated, 860 square foot wetland, located on the street side of the property. The applicant would like to restore function and value to the altered wetland system. The majority of the wetland has been filled over the past several decades from decayed leaf matter and road sand which has previously entered the system through a faulty municipal drainage swale which abuts the subject wetland. Maintenance activities were performed on the drainage swales by the Town during the summer of 2009. Prior to these activities the primary water source of the wetland consisted of storm water directed to the area from the eastern extents of Birchwood Road through the municipal storm sewer system. Since the completion of the maintenance activities, storm water has continued to bypass the wetland system and is directed to a drain inlet located at the northwestern corner of the property. The wetland no longer has a hydraulic connection to its former primary water source. Visual indications of hydrology within the wetland include water stained leaves, drainage patterns and root buttressing. Test pits completed by the application to average depths of

2.5 feet reveal the presence of layers of sand, gravel and decayed leaf matter (ranging in thickness from 6" to 2') which overlie horizons of hydric soils.

The applicant wishes to restore functions to the wetland by:

- Remove sill material and re-establish natural grades to restore hydrologic regime and promote water ponding and retention.
- Eliminate invasive plant species.
- Provide flood water storage and storm damage protection.
- Improve water quality.
- Reduce sediment loading.

The applicant wishes to restore values to the subject wetland by:

- Enhance wetland biodiversity through plantings of indigenous wetland plant species.
- Encourage bird and wildlife habitat.
- Deter mosquito habitat.

This request requires a Minimum Impact Dredge & Fill.

Mr. Morris suggested Mr. McRobbie contact Mr. Jack McCartney, Windham Road Agent, before beginning work on this project.

45 Abbott Road – Lot 25-F-114, Dredge & Fill

Replacement of 80 square feet of retaining wall along pond and behind beach area.

Work completed without a permit in October 2008.

160 square feet of new impacts to wetland.

Mr. Joseph Maynard of Benchmark Engineering explained that the applicant received a violation notice from NH DES. The concrete retaining wall was built in the original location. NH DES has put an administrative order on the property until the situation is resolved. The wall was already completed when the Conservation Commission did its site walk.
